AFFILIATION AGREEMENT

BETWEEN

A.C. REGGIANA 1919 AND OLYMPIA FC



Premise

Always A.C. Reggiana and the "granata" color represent professional football in our Province, with particular attention to grassroots activities and the youth sector which we intend to confirm and relaunch with this "Provincia Granata" project, which aims to strengthen our bond with the non professional clubs and with our entire territory, promoting sporting, but also cultural, educational and ethical activities, in collaboration with training bodies and local institutions.

And bearing in mind that Reggio Emilia was a benchmark for Italy during the international struggle against the Apartheid regime. Specifically, Reggio Emilia was the first city in the world to sign a Solidarity Pact with the African National Congress, in 1977, thanks to which they acted to end all forms of colonialism, for freedom, peace and together in the fight against Apartheid and racism. This bond was further strengthened in 2012 thanks to the cooperation with HIP Alliance (Italian Section) and Gauteng Province. This agreement is stipulated under the patronage of the MoU signed in 2022 between Sport's Foundation and Gauteng Sport Council.

Affiliation agreement

Between

- **A.C. Reggiana 1919**, represented by its legal representative, Carmelo Salerno born on 3/1/1971 in Montegiordano (CS);
- and**
- **Olympia FC**, represented by its legal representative, Giovanni di Benedetto born on Johannesburg in 07/02/1970;



the following is agreed and stipulated

1. Information for members

- The affiliated company undertakes to inform (through a note on the official website, presentation letter and use of the logo as per the following point) its members and their families about the existence of this agreement, illustrating its contents and purposes.
- A.C. Reggiana 1919, through its Press Office, will publicize the stipulation of this Affiliation and the related events indicated in the following points in local newspapers and on its official website.

2. Permission to use the A.C. logo Reggiana 1919

- A flag or the AC logo must be displayed near the headquarters and/or within the training/playing fields of the Affiliated Club. Reggiana 1919, which will be supplied by the latter.
- The affiliated company will have the opportunity to use the A.C. logo. Reggiana 1919 for its development and communication initiatives according to methods previously agreed and validated by the A.C. Marketing Manager. Reggiana 1919.



3. Technical training

- Seminars with A.C. coaches will be planned and organized for the coaches of the affiliated clubs. Reggiana.
- Moments of theoretical training in the classroom and/or remotely will be planned and organised, for the coaches of the affiliated clubs, with tools that will be defined, according to the quarterly program that will be sent to the Technical Management of the affiliated club.
- "Ad hoc" meetings will be scheduled by A.C. coaches. Reggiana, on specific topics proposed by the affiliated companies.
- Training moments will be planned and organised, for the coaches of the affiliated clubs, with the staff of the A.C. Goalkeeper Coaches. Reggiana.
- Training moments will be planned and organized with the staff of the A. C. Reggiana Athletic Trainers to share a "motor" program with the coaches of the Affiliated Clubs relating to both basic and competitive activities.

4. Granata Stadium Project

- A.C. Reggiana 1919 offers its affiliated clubs promotions for access to the Città del Tricolore Stadium in the East Stand sector of its members, to allow them to attend the First Team matches for free or at discounted rates.



5. Reggiana Store

-For members of affiliated companies, there is a 5% discount on purchases of materials made at the Reggiana Store, with the exclusion of products on sale.

6. Friendlies and other matches

-Test matches will be scheduled between the teams of A. C. Reggiana and those of the Affiliated Clubs.

-There will be groupings called "Regia Day" on the fields of the Affiliated Clubs which will consist of "educational" test matches with different vintages of the two clubs.

7. Scouting and player recruitment

-There is no restriction or obligation for Reggiana to register any profiles of interesting young people from the Affiliated Clubs.

-Training moments will be provided on scouting techniques and analysis of the kids' skills, in order to define a shared approach both on the evaluation of their level and of the related technical and athletic growth programs.



8. Regia Camp

-The athletes of the Affiliated Clubs will have the opportunity to participate in the Camps organized by A.C. Reggiana 1919 ASD at more favorable prices and conditions.

9. Duration and Renewal

- This agreement, which regulates its contents, will concern the 2023-24 Sports Season, in particular from 1 July 2023 to 30 June 2024.

- This agreement is considered tacitly renewed from year to year, if none of the parties cancels it by registered mail. or PEC at least three months before each annual deadline.

- In the event of regular termination of the agreement, neither party will have the right to claim compensation or compensation of any kind.

10. Right of withdrawal

- If one of the parties does not respect the commitments undertaken by signing this Affiliation Agreement, the other will have the right to withdraw which must be communicated in writing by registered mail. or PEC and will take effect immediately.



11. Conventional Court

- Any dispute that may arise regarding the interpretation, execution or termination of this contract will be referred to the jurisdiction of the Court of Reggio Emilia (RE).
